#### I. INTRODUCTION

Nitrite reductase refers to any of several classes of enzymes that catalyze the reduction of nitrite. There are two classes of NIR's. A multi haem enzyme reduces  $NO_2^-$  to a variety of products. Copper containing enzymes carry out a single electron transfer to produce nitric oxide.

Nitrite Reductase Microplate Assay Kit is a sensitive assay for determining Nitrite Reductase activity in various samples. Nitrite reductase can reduce  $NO_2^-$  to NO.  $NO_2^-$  can react with dye reagent, and can be measured at a colorimetric readout at 540 nm. The reduction of  $NO_2^-$  is proportional to the nitrite reductase activity.



## **II. KIT COMPONENTS**

#### Note:

Substrate: add 2 ml distilled water to dissolve before use.

Dye Reagent: add 10 ml Dye Reagent Diluent to dissolve before use.

**Standard:** add 1 ml distilled water to dissolve before use; then add 20  $\mu$ l into 980  $\mu$ l

distilled water. The concentration will be 2 mmol/L.

# III. MATERIALS REQUIRED BUT NOT PROVIDED

- 1. Microplate reader to read absorbance at 540 nm
- 2. Distilled water
- 3. Pipettor, multi-channel pipettor
- 4. Pipette tips
- 5. Mortar
- 6. Ice
- 7. Centrifuge
- 8. Timer



#### IV. SAMPLE PREPARATION

## 1. For cell and bacteria samples

Collect cell or bacteria into centrifuge tube, discard the supernatant after centrifugation, add 1 ml Assay buffer for  $5 \times 10^6$  cell or bacteria, sonicate (with power 20%, sonicate 3s, interval 10s, repeat 30 times); centrifuged at 4000g 4 °C for 5 minutes, take the supernatant into a new centrifuge tube and keep it on ice for detection.

## 2. For tissue samples

Weigh out 0.1 g tissue, homogenize with 1 ml Assay buffer on ice, centrifuged at 4000g 4 °C for 5 minutes, take the supernatant into a new centrifuge tube and keep it on ice for detection.

## 3. For liquid samples

Detect directly.



#### V. ASSAY PROCEDURE

Add following reagents into the microcentrifuge tube first:

Mix, put it in the oven, 37 °C for 30 minutes.

Mix, centrifuged at 10,000g 4 °C for 10 minutes, add the supernatant into the						
microplate.

Mix, record absorbance measured at 540 nm.						

#### Note:

- 1) Perform 2-fold serial dilutions of the top standards to make the standard curve.
- 2) For unknown samples, we recommend doing a pilot experiment & testing several doses to ensure the readings are within the standard curve range. If the enzyme activity is lower, please add more sample into the reaction system; or increase the reaction time; if the enzyme activity is higher, please dilute the sample, or decrease the reaction time.
- 3) Reagents must be added step by step, can not be mixed and added together.



#### VI. CALCULATION

**Unit Definition:** One unit of NiR activity is defined as the enzyme reduce 1  $\mu$ mol of NO<sub>2</sub>- per minute.

## 1. According to the protein concentration of sample

NiR (U/mg) = 
$$(C_{Standard} \times V_{Standard}) \times (OD_{Control} - OD_{Sample}) / (OD_{Standard} - OD_{Blank}) / (C_{Protein} \times V_{Sample}) / T$$

$$= 0.0667 \times (OD_{Control} - OD_{Sample}) / (OD_{Standard} - OD_{Blank}) / C_{Protein}$$

# 2. According to the weight of sample

NiR (U/g) = (C<sub>Standard</sub> × V<sub>Standard</sub>) × (OD<sub>Control</sub> - OD<sub>Sample</sub>) / (OD<sub>Standard</sub> - OD<sub>Blank</sub>) / (V<sub>Sample</sub> × W/ V<sub>Assay</sub>) / T
$$= 0.0667 \times (ODControl - ODSample) / (ODStandard - ODBlank) / W$$

## 3. According to the quantity of cells or bacteria

NAG (U/10<sup>4</sup>) = (C<sub>Standard</sub> × V<sub>Standard</sub>) × (OD<sub>Control</sub> - OD<sub>Sample</sub>) / (OD<sub>Standard</sub> - OD<sub>Blank</sub>) / 
$$(V_{Sample} \times N / V_{Assay}) / T$$
= 0.0667 × (OD<sub>Control</sub> - OD<sub>Sample</sub>) / (OD<sub>Standard</sub> - OD<sub>Blank</sub>) / N

C<sub>Protein</sub>: the protein concentration, mg/ml;

 $C_{Standard}$ : the concentration of standard, 2 mmol/L = 2  $\mu$ mol/ml;

W: the weight of sample, g;

N: the quantity of cell or bacteria,  $N \times 10^4$ ;

V<sub>Standard</sub>: the volume of standard, 0.02 ml;

V<sub>Sample</sub>: the volume of sample, 0.02 ml;


V<sub>Assay</sub>: the volume of Assay buffer, 1 ml;

T: the reaction time, 30 minutes.



## VII. TYPICAL DATA

The standard curve is for demonstration only. A standard curve must be run with each assay.



Detection Range: 0.02 mmol/L - 2 mmol/L
